 - b. First-generation college student: A student whose parents or guardians did not complete a 4-year college degree
 - c. 18.4% of MSU undergraduate students are first gen
 - d. 19.9% of the 2025 cohort identify as first-gen
 - e. 6-year graduation rate of 29.1% (2019 cohort)
 - f. All this data is self-reported
 - g. National First-Generation College Celebration is coming up
 - a. Annually on November 8th
 - b. Featured on FirstGen Forward's website
 - h. First-Gen Forward Network at MSU
 - a. Accepted into the network in 2023 with 75 other institutions
 - b. Working team: Mackenzie Spence, Alisha Downs, and VP Steven Swinford
 - c. There are three steps in the network journey and MSU is still in step one
 - i. Committee successes:
 - a. First-scholars network

- c. *Mary Lachenbruch – Montana University System Executive Director of Insurance & Benefits*
- i. *Provide insight on benefits on the University System level*
 - a. Health insurance is what people first think of but there is also:
 - a. Life
 - b. Eye
 - c. Dental
 - b. Mary reports to Commissioner of Higher Education
 - c. 14 campus sites across the state
 - d. Do not bargain for benefits
 - a. There is an inter-unit benefits committee
 - e. Mary and Commissioner Christian are the fiduciary of the plan
 - f. Employee benefits are complex and challenging
 - g. Balancing decision making with State Legislation
 - h. Compared to the past, costs of prescription drugs and their insurance coverage have changed
 - i. There is a co-pay for specialty medications
 - j. MUS is a self-funded plan
 - a. Collecting all premiums and pooling them together and then using premiums to pay the bills
 - b. They carry the risk
 - k. A unique benefit is no co-pay for the first four visits to a mental health provider
 - l. Self-funding gives some flexibility in areas and none in other areas
 - m. Living situation in Gallatin Valley:
 - a. Actuaries prepare an analysis every few years
 - b. Compared our insurance to other insurance plans for other Gallatin County insurance plans
 - c. All employees for all benefit types are going to be completely covered in whole (this is just employee and not dependents)
 - n. MUS system offers two well checks a year
 - a. Tests have been added over the years, such as vitamin D
 - b. Another one added is for chronic kidney disease tests

- o. Long-term disability is a mandatory benefit
- p. Question answers:
 - a. If you have a question about a specific medication there is someone to reach out to
 - b. University has own fee schedule for reimbursements
 - c. Biggest impact for Delta Dental providers has been seen in the Gallatin Valley
 - d. Pharmacy contract is up on June 30th, so they are having weekly meetings about this
 - e. Anyone on a plan is subsidizing those with families
 - i. A single person helps pay the premiums for families
 - f. A benefit not enough people take advantage of is Well Baby
 - i. Waiving co-pays on prenatal visits
 - g. They will be revamping wellness benefits
 - h. People do not pay attention to beneficiaries for life insurance and make sure they are updated
 - i. Make sure to have a contingent as well as a primary
 - ii. Cannot send a check to a minor, need to have a trust set up for them

d. Jeannette Grey Gilbert – MSU Chief Human Resources Officer

i. Provide insight on benefits from the MSU perspective

- a. President's Compensation Advisory Council met last week and is talking about strategy
- b. A website is being worked on for wellness benefits that employees will have access for free
- c. Two programs that are underutilized are the supplemental retirement plans
 - a. Can put pretax money aside
- d. Overall cost of healthcare continues to increase, so they are trying to set themselves up for best position possible
- e. This year there was about a 10% increase
