Montana Rural Physician Incentive Program (MRPIP)

- Originally authorized by the 1991 Montana Legislature
- Established to encourage primary care physicians to practice in rural, medically underserved areas of Montana, or serve underserved populations
- Funded through a trust which facilitates the repayment of qualified medical education debts of participating physicians.






Program Benefits/Obligations

- MRPIP provides up to \$150,000 in medical education loan repayment
- Disbursed over one- to five-year periods of service in approved rural or underserved locations
- Graduated payments, based on length of service, are disbursed directly to verified lending institutions of the participating physician; amounts can be prorated for less than full-time practice

Characteristics of Qualifying Locations

- MRPIP is designed to help rural and medically underserved communities or areas serving medically underserved populations that have difficulty attracting and maintaining adequate numbers of physicians; most commonly, these areas are:
 - Communities with populations of fewer than 8,000
 - Hospitals with fewer than 50 beds
 - Communities demonstrating shortages of physicians serving specific populations
 - Federally Qualified Health Centers (FQHCs) and Community Health Centers (CHCs)
 - Have high RUCA and HPSA scores
 - Many of these areas have been designated as HPSA's, MUA's or MUP's

Application Process

- Application process is online through Award Montana Portal
- Annual application cycle from May 1st August 1st
- Joint application process applying physician & supporting institution site
- A separate loan information/verification form must be completed for educational loans being submitted for repayment consideration.
- Program Requirements:
 - MD or DO degree is required
 - Valid State of Montana Medical License
 - Qualified Medical Education Loans



Selection Process

- Applications are compiled by OCHE staff for review by an advisory committee, who recommend the number of new applicants to be funded each cycle.
- Qualified applications are prioritized for participation based upon community needs and the availability of funds.
- Preference is applied to:
 - Physicians who practice in remote rural, underserved locations, or locations having difficulty attracting physicians
 - MT WICHE, WWAMI, and ICOM graduate physicians who contributed to the MRPIP trust fund
 - Physicians practicing in a high-demand field (primary care, family medicine, etc.)


Montana Communities Served by MRPIP

How is MRPIP Tied to WICHE, WWAMI and ICOM?

- All WICHE, WWAMI, and ICOM state-supported MD and DO students are required to pay an annual MRPIP fee assessment each year of their medical program as a condition of receiving the state support (total of 4 years)
- The fee is mandated by state law and is paid directly to OCHE. These fees are invested and used to fund the MRPIP loan repayment program
- The MRPIP annual fee amount is calculated as a percentage of the annual WICHE support fee rates for Allopathic and Osteopathic fields of study to create the standard fee amount for each field
- For WWAMI & ICOM students, the type of contract selected will dictate the amount of their MRPIP fee
